- 1) Seller hereby agrees and guarantees that said dog is in good health and free of any illness or disease for a period of 72 hours after purchase or shipping date. If said dog should require veterinary attendance in this period for illness or disease, Seller agrees to pay all reasonable veterinary expenses upon receipt of an itemized statement from the attending veterinarian. Receipt must be accompanied by a statement from said veterinarian that the disease was contracted prior to the 72-hour period. This guarantee DOES NOT extend to payment for veterinary attendance due to negligence, mistreatment or accident, or for regular veterinary examination or shots. Buyer agrees to properly care for the dog.
- 2) The litter has had their eyes examined by a certified ophthalmologist and all are certified clear of the genetic diseases CEA and PRA.
- 3) The litter has had their hearing checked by use of a BAER test and all are certified bilateral normal.
- 4) This dog has AKC Limited Registration. The dog is eligible for participation in any and all performance competition however it is not eligible for conformation showing or breeding. Any puppies resulting from any breedings are NOT eligible for AKC registration.
- 5) Seller agrees that the puppy has been micro-chipped and had appropriate shots before leaving.
- 6) If puppy is being shipped, buyer agrees to pay all expenses related to shipping which include airfare and a crate as well as a health certificate.
- 7) Seller will forward to Buyer registration and pedigree when payment in full is received.
- 8) In the event that said dog is returned to Seller, Buyer agrees to return all registration papers.
- 9) If at any time Buyer wishes to sell or give away said dog, Buyer agrees to notify Seller and Seller shall have first right of refusal.
- 10) Buyer agrees to have said dog neutered/spayed before 1 year (males) or 7 months (females).
- 11) Buyer agrees to have OFA x-rays performed at 24 months of age and forward results to Seller.
- 12) Buyer understands that this dog is not to be used for breeding.
- 13) Buyer agrees to send Seller periodic updates of the dog's progress and accomplishments.
- 14) Buyer agrees to use "Czechmate" (no 's) as the first word in said dog's AKC registered name.
