- 1) Seller hereby guarantees that said dog will be free of the following: Hip Dysplasia, Hereditary Eye Disease, Deafness, Undershot or Extreme Overshot Bite, Undescended Testicles (males). If the animal is found, by a qualified veterinarian, to have any of the above problems by 2 years of age, Buyer will have the choice of the following options:
  - A) Buyer may keep the dog and have it spayed or neutered. Seller will refund half of the purchase price when spay/neuter is confirmed by a veterinarian.
  - B) Buyer may return the dog to Seller. Buyer will receive a replacement pup from the next litter bred. The replacement must be agreeable to both parties.
- 2) Seller hereby agrees and guarantees that said dog is in good health and free of any illness or disease for a period of 72 hours after purchase or shipping date. If said dog should require veterinary attendance in this period for illness or disease, Seller agrees to pay all reasonable veterinary expenses upon receipt of an itemized statement from the attending veterinarian. Receipt must be accompanied by a statement from said veterinarian that the disease was contracted prior to the 72-hour period. This guarantee DOES NOT extend to payment for veterinary attendance due to negligence, mistreatment or accident, or for regular veterinary examination or shots. Buyer agrees to properly care for the dog.
- 3) Seller agrees that puppy will have been micro-chipped and had appropriate shots before leaving.
- 4) If puppy is being shipped, buyer agrees to pay the shipping expenses which include airfare and a crate as well as a health certificate.
- 5) Seller will forward to Buyer registration and pedigree when payment in full is received.
- 6) In the event that said dog is returned to Seller, Buyer agrees to return all registration papers.
- 7) If at any time Buyer wishes to sell or give away said dog, Buyer agrees to notify Seller and Seller shall have first right of refusal.
- 8) Buyer agrees to have OFA x-rays performed at 24 months of age and forward results to Seller.
- 9) Buyer understands that both CEA and TNS DNA tests must be performed before the dog is used for breeding.
- 10) Seller will remain as a co-owner until all required health tests are performed.
- 11) Buyer agrees to send Seller periodic updates of the dog's progress and accomplishments.
- 12) Buyer agrees to use "Czechmate" (no 's) as the first word in said dog's AKC registered name.

**NO OTHER WARRANTIES, EXPRESSED OR IMPLIED, ARE MADE UNDER THIS CONTRACT. IF SAID DOG IS BRED BEFORE TWO (2) YEARS OF AGE, OR BEFORE COMPLETING NECESSARY HEALTH CHECKS (OFA & CERF), THIS CONTRACT IS NULL AND VOID.**
